STORAGE AND HANDLING

ROVISOME® Retinol Moist should be stored in a dark area at 4 °C in the original packaging and protected from direct sunlight. Keep the container tightly sealed to prevent microbial contamination.

ROVISOME® Retinol Moist stored unopened in the original PE container has a shelf life of 12 months with respect to the specification parameters.

Before usage: Warm up the product at room temperature to dissolve crystals.

Gently shake or agitate the product prior to usage in a formulation.

USAGE

Product can easily be processed into final formulations by stirring at 30 °C. Typical use level for ROVISOME® Retinol Moist is 1- 3%.
